Joanne reported that she started on March 1, 2023, full time. She stated that she had excellent onboarding and has received wonderful support from everyone she has met in the Calumet County Courthouse. She expressed gratitude to the CDEB members for their support.

Joanne indicated that she has been meeting with various individuals and groups to prepare for the likelihood of approximately 50 educators joining the Calumet County staff. Examples include meetings with superintendents and directors/coordinators of special education in Brillion, Chilton, Hilbert, New Holstein, and Stockbridge as well as representatives from The Wisconsin Department of Public Instruction, DPI, and various people who work for Calumet County such as the Directors of Human Resources and Finances.

Joanne shared that many tasks have been completed for example: draft job descriptions, data sheets, and a question-and-answer document for educational leaders who are impacted. In addition, she has been meeting with Calumet County leaders such as representatives from the Aging and Disabilities Resource Center, ADRC, Birth to Three, and various human services leaders and has made some positive connections that will serve students and those who serve them in Calumet County well.

Starting in June the superintendents and directors and coordinators of special education will be coming together with her to talk about the future vision for the program.
