

Calumet County Highway Committee Meeting Minutes May 12, 2021

The meeting was called to order by Highway Committee Chair Kenneth Draheim at 8:30 a.m.

Members present were: Supervisors Kenneth Draheim, Matthew Budde, Bill Barribeau, James Wyngaard, and Joseph Mueller.

Others Present were: Highway Commissioner, Brian Glaeser; Highway Road Superintendent, Chad Scheinoha; and Highway Office Manager, Michelle Maas.

The pledge of allegiance was recited.

Moved by Supervisor Barribeau, seconded by Supervisor Mueller to approve the agenda. Motion carried unanimously.

Moved by Supervisor Budde, seconded by Supervisor Wyngaard to approve the minutes from the March 10, 2021 Highway Committee Meeting. Motion carried unanimously.

Items for Action or Discussion:

A. Draft Resolution to Amend the Calumet Code of Ordinances to add a 45 mph Speed Limit Zone on CTH D from the Intersection of CTH KK/Man-Cal Road to 307 feet south. (Attachment 1):

Commissioner Glaeser informed the Committee that the Brown County Highway Department had changed the speed limit on their section of CTH D north of CTH KK/Man-Cal Road. They requested that we change our speed limit on the south side to coincide with their speed limit change. Committee discussion followed. **Moved** by Supervisor Budde, seconded by Supervisor Wyngaard to approve the Resolution to add a 45 mph speed limit zone on CTH D and forward to the County Board for approval. This changes will then coincide with the speed zone on the north side of the intersection as per staff recommendation. Motion carried unanimously.

B. Draft Resolution to Amend the Calumet Code of Ordinances to add a 45 mph Speed Limit Zone on CTH EE from 600 feet east of Lakeshore Drive to 1000 feet west of Lakeshore Drive. (Attachment 2):

Commissioner Glaeser informed the Committee that the department has received complaints regarding speeding on CTH EE heading to and from Calumet County Park. So to slow traffic down the department would like to add a 45 mph speed zone from 600 feet east of Lakeshore Drive to 1000 feet west of Lakeshore Drive. Committee discussion followed. **Moved** by Supervisor Budde, seconded by Supervisor Mueller to amend the Resolution as presented by staff, and have the speed limit zone on

CTH EE begin at the intersection of State Trunk Highway 55 and extend west to 1000 feet west of Lakeshore Drive. Motion carried unanimously.

C. Draft Resolution to Amend the Calumet Code of Ordinances to amend the 35 mph Speed Limit Zone on CTH EE from the Calumet County Park Entrance to 1000 feet west of Lakeshore Drive.

(Attachment 3): Commissioner Glaeser informed the Committee that the department will also slow traffic going to and from the County Park by extending the 35 mph speed zone from the County Park Entrance to 1000 feet west of Lakeshore Drive. Committee discussion followed. **Moved** by Supervisor Budde, seconded by Supervisor Mueller to approve the Resolution to amend the 35 mph speed limit zone on CTH EE from the Calumet County Park Entrance to 1000 feet west of Lakeshore Drive as recommended by staff. Motion carried unanimously.

- Commissioner Glaeser provided the committee with a handout of recent activities of the department and staff.

B. WCHA Update:

- Commissioner Glaeser reminded those attending that the Summer Road School is June 7-9, 2021, and that the WCHA is still looking to fill the position of Deputy Director.

C. CTH N Update:

- Commissioner Glaeser informed the Committee that the Public Informational Meeting was held on April 13, 2021. The final design plan is close to completion. The next step in the process will be to hire a firm to purchase the Right of Way needed in a few areas. Construction is slated for 2022.
