Items for Action or Discussion:

- A. Resolution to County Board to Recognize Snowplow Driver Achievements at APWA Snowplow Roadeo: Each year the American Public Works Association (APWA)- Wisconsin holds an annual Snow Plow Roadeo. The past couple years the Department has sent a handful of drivers to compete in the competition. This year our department had two first place finishers. The first was Highway Road Superintendent, Chad Scheinoha who placed first in the Superintendents competition and brought back the "Director's Cup." This is a traveling trophy that remains at our department for one year. And for the second year in a row employee Mike Loose placed first in the Drivers Competition. Mike went on to the National Competition in Denver, Colorado where he placed 9th out of 47 teams. This resolution will recognize them for their excellent performance. Committee discussion followed. Wednesday, November 9, 2022 at 2:00 p.m. There was only one Bid received. The bid is from Wheeler Builders with a price of \$566,160.00. Staff have reviewed the bid and would recommend that the bid from Wheeler in the amount of \$566,160.00 be accepted. Committee discussion followed. **Moved** by Supervisor Dietrich, seconded by Supervisor Mueller to accept the bid from Wheeler Builders as per staff recommendation. Motion carried unanimously.
